Vendors supply their own tables, canopies, chairs, extension cords, etc. and carts for your booth.

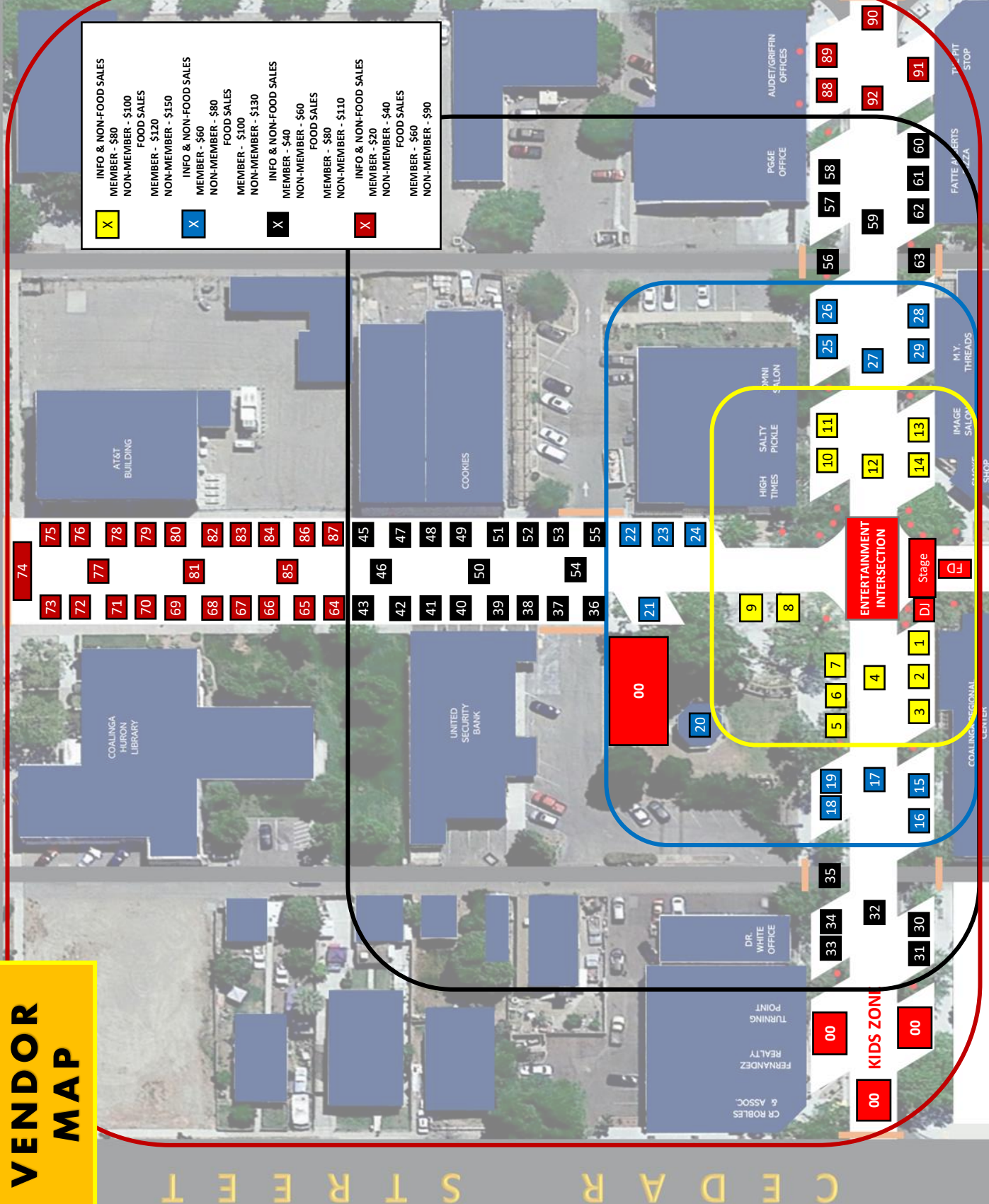
